

## **BMS Preschool Scholarship**

### **2024-2025**

Dear Prospective Family,

We are so glad you are interested in joining the Bloomington Montessori Community!

Bloomington Montessori School (BMS) offers one scholarship a year for an incoming three-year-old child. If no applications are received for an incoming three-year-old, then applications for other age groups will be considered. This scholarship is intended to serve children who would otherwise be unable to attend BMS due to financial reasons.

A scholarship recipient may enter as a three-year-old “youngest-group” student and potentially remain through sixth grade. Scholarships are reassessed and renewed annually based on evidence of continued financial need.

Scholarships cover full tuition for the regular academic year and summer camp enrollment. Lunch and Elementary Aftercare are not included, but free and reduced lunch applications are available.

Applicants will be considered upon submitting a current annual income tax return of household income at or below 200% of the current year’s Poverty Guidelines for the Contiguous States and the District of Columbia ([aspe.hhs.gov](https://aspe.hhs.gov)) with their completed scholarship application.

Applications for the upcoming school year must be received by February 29, 2024. Applications will be reviewed in March, and a decision will be communicated by March 25, 2024. A financial agreement reflecting the scholarship offer must be signed and returned by April 12, 2024.

If you have not already done so, an admissions application must also be on file for the applicant's child. Scholarship applicants qualify for a reduced application fee of \$35 (which covers the school’s costs). Please notify the office when you are ready to submit your application so your fee can be processed correctly.

Families applying for a scholarship are required to tour the school. Please call to schedule a visit (812-3362800) if needed!
